Scholarship Policy

What are the requirements?

I. WHO QUALIFIES?

- A) The applicant must be an active member of a Christian Endeavor Society in a local church, which is a member of an Island Christian Endeavor Association (if organized), for a minimum of one (1) year.
- B) The applicant must be a high school graduate.
- C) The applicant will be selected according to the following priorities pursuing Studies in the field of:

Religious Vocation Serving in a State Christian Endeavor Church

Seminary – to further develop those currently serving in the ministry and/or those with a desire to seek academics in Ministry to serve their local Christian Endeavor Hawaii Churches.

Continuing Education — available to allow those currently ministering in their local Christian Endeavor Hawaii churches to include: educational, music, pastoral & youth ministry, to improve, enhance their current ministry skills.

II. HOW TO APPLY FOR A SCHOLARSHIP

- Applicants must apply through their local church Christian Endeavor Society which gives its approval. (Please provide church minutes and recommendations)
- Upon approval, the application is sent to the Island Christian Endeavor Representative for signature and approval, then a copy is sent to the State Scholarship Committee Chairperson at the address below:

- The State Christian Endeavor Scholarship committee will process all applications 90 days prior to the start date of each school year or semester.
- When an application has been approved, the awarded will be required to sign a Promissory note. (see III C and D below)

III. WHAT ARE THE REQUIREMENTS AND STIPULATIONS?

- A) Total Scholarship awarded as follows:
- * Christian Education \$1,000 a year max.
- ** Seminary \$5,000 a year max.
- *** Continuing Education \$2,000 a year max.
- B) The award will be sent to the college by the Treasurer of Christian Endeavor Hawaii. In the event that a college will not accept the award, it will be Sent to the recipient. Continuing Education recipients, the award will be sent to the applicant.
- C) If the applicant is unable to complete his/her course of study, the Scholarship Committee must be notified within thirty (30) days. The Scholarship Committee will then review the individual's situation and determine Whether or not the award will become a loan. If the Scholarship committee determines that the investigation is proven unjustified the applicant must then repay this loan with no interest attached.
- D) The applicant must be able to serve/participate in a CE Hi church or CE Hi organization.
